

### Shared Harvest – The Elgin Food Cooperative Nov. 13, 2023 Annual Shareholder Meeting Minutes

- Jen Abbey called the meeting to order at 7:02 p.m. at the Meadows Community Room C at Gail Borden Public Library and live via Zoom.
- Board members present: Gail Cohen, Allison Goodman, Jeremy Hayes, Jen Abbey, Rebecca Lagesse, Martin Nobs, and Jennifer Shroder.
- Jen A. welcomed everyone to the meeting, presented the agenda and current board members.
- Rebecca presented a brief refresher on What is Shared Harvest and our purpose.
- Rebecca presented 2022 annual meeting minutes. Jen Abbey moved that we approve the minutes,
- and Allison Goodman seconded. Motion carried.
- Gail presented the financial report from Nov. 1, 2022 through Oct. 31, 2023 (see deck). Loans in escrow are being paid back as the former capital campaign did not result in the Spring Street location for our store.
- Jen A. kicked off the Year In Review detailing community outreach, events, tasks and education we have taken part in. C
  - Community presentation "The Future of Grocery Store Cooperatives" and invited attendees to have Shared Harvest present to groups they're a part of.
  - We hosted a Spring Picnic in partnership with UUCE and McQueen Station Farm. It included a potluck and farm tour.
  - We were present at Elgin's first ever Pride Parade and Festival, Juneteenth Cultural Festival, and End of Summer Bash.
  - Some board members took part in a free webinar series hosted by Food Co-op Initiative (FCI) over the summer,
  - In Sept. Shared Harvest representatives attend FCI's annual Up & Coming conference in St Paul.
  - We are participating in monthly peer group calls through FCI with four other co-ops also in development stage 2B.
  - We are networking with elected officials at all levels to ensure awareness for future grant/funding opportunities and our media kit is being refreshed to help facilitate this.

- Allison talked about our presence at the 2023 Downtown Elgin Farmers Market. We enjoyed connecting with attendees over the course of the season, sharing vegetable temporary tattoos and being recognized for Meet Your Neighbor Day. We sold two DIY Farm to Table meal kits (Salsa kit and pizza kits) which were delicious and well received. In early October we hosted our Farm to Table Dinner which due to cold weather was held indoors at the Centre of Elgin's Heritage Ballroom. Chef Greg Shannon of Elgin Public House worked with our wonderful farm partners to put together a fantastic event. We again partnered with Elgin Symphony Orchestra to offer discounted tickets to that evening's show to our dinner attendees. Allison thanked all of our volunteers for helping in so many ways over the course of the past year.
- Martin presented A Look Ahead noting that our co-op organization is currently in development stage 2B, and our current task is to evaluate potential sites/update market study. He presented the board's current priorities for the store location including being downtown (or downtown-adjacent) to promote economic development in Elgin, being walkable/bikeable/access to public transit. Online and in person discussion shared agreement that we should continue to focus on the downtown area. Martin presented our Top 3 Goals & Priorities for 2024 which include 1) Locking in a site, 2) Expanding Shareholder & Community Relationships (finding expertise in legal, finance, grants, construction, marketing to join the board or serve on a volunteer team), and 3) Growing # of Shareholders.
- Election: Jeremy introduced board nominee Virginia T. Motion to accept the board candidate came from Rebecca, Gail seconded. Motion carried.
- Carol led a Q&A session during which location priorities and goals for 2024 were reviewed. All attendees were entered into prize drawing for Equal Exchange products and five names were drawn. Jen A. will coordinate delivery for those attending online.
- Motion to adjourn from Jen A. at 8:10 p.m. and was seconded by Rebecca. Motion carried.



### 2024 Site Evaluations: USDA Food Desert Map



## Seeking 6000 to 9000 sq. ft. with ample parking and loading area

- The building committee reported on multiple locations that were for sale or lease in downtown Elgin in 2024. None of them met our criteria for size, parking or loading area.
- Multiple feasibility studies of city-owned parcels (completed pro bono by a professional architect) were shared.
- Shareholders and community members who would like more information on these studies, or are interested in joining the Building Committee, are invited to reach out to arrange a meeting.

### Progress in 2024

- Preliminary conversations with the City of Elgin about city-owned sites.
- Construction estimates for a new build (Gallant Building Solutions who completed Food Shed) on one of the three most feasible sites.
- N Grove was deemed to be the least expensive; preliminary construction estimate around \$4MM for a "gray box."
  - Initial estimates for additional improvements, equipment, pre-opening personnel, contingencies, etc. is ~\$2.5-4MM (under refinement, bids).
- Remaining open to For Sale / Lease coming on the market.
- Currently exploring a mixed-use residential partnership. Another entity would build; Shared Harvest would lease.

\$250K for implementation.
Loans \$500K to \$5MM may be paired with grant.



We received 194 full applications, requesting over \$24,000,000 total – more than four times the \$6,000,000 that was made available for grant awards.

We are pleased to inform you that ELGIN FOOD COOPERATIVE has been selected for a grant award. We can award up to \$150,000.00 to the SHARED HARVEST GROCERY CO-OP project. Your award is contingent upon satisfactory receipt of all required documents, agreement to terms & conditions and ongoing reporting responsibilities, and a fully executed Grant Agreement. Your organization must be prepared to meet the conditions in this letter and begin work on your project within 90 calendar days of the date of this letter.

### Challenges


- New building cost (~\$4MM) + interior improvements, equipment, pre-opening personnel, contingencies, etc. (~\$2.5-4MM) significantly exceeds maximum grant award.
- Things are not far enough along to have city approvals by Dec 2.
- Applicants are required to provide 25% of total project cost, representing a 1:3 match.
- Timing of the grant deadline and realities of fundraising timeline and local bids are not well aligned.
- Unknown if a third round will be offered by the state.

#### Established Fiscal Sponsorship with CDS



Registered to accept tax-deductible donations for its clients in all states across the nation to help co-ops reach their fundraising goals.

Currently working with 25+ U.S. co-ops including Chicago Market, Food Shed, Prairie Food Co-op and Wild Onion Market.



Shared Harvest is a community owned grocery store coming to Elgin with affordable, healthy, and locally-produced food.

# Financial Report





#### Financial Report

• Shareholders who would like more information on the financial report shared at the annual meeting, or who would like to join the Finance Committee, are invited to reach out to arrange a meeting.

#### What are Preferred Shares?

- To be an owner/member of Shared Harvest, a person must own at least one share of **Common Stock**. Shared Harvest set the value of this stock at \$100 in 2012.
- Since 2012, state law evolved to allow co-ops to offer additional forms of shares. Now many startup co-ops use **Preferred Shares** offered at a higher price point to raise capital.
- In order to offer Preferred Shares, Shared Harvest needs to amend its bylaws and articles of incorporation. A proposal to do so will be voted on by shareholders this evening.

#### Preferred Shares Next Steps

#### Following bylaws amendment:

- Work with our attorney to file amendment to articles of incorporation.
- Complete prospectus outlining details of the Preferred Shares offering. Many co-ops offer Preferred Shares at \$1000 or \$2000.
- Owners purchasing Preferred Shares will retain at least one \$100 Common Share to sustain ownership benefits.
- Owners of multiple Common Shares can convert some to Preferred Shares (individual limit of owning ten total shares per IL law).

# Proposed Bylaws Changes

#### Discussion Item: Quorum

Current bylaws require 50 shareholders to constitute a quorum at business meetings.

The board's opinion and experience shows that getting to 50 is challenging.

The proposal changes our quorum requirement to 35 owners or 5% of all owners, whichever is less.

The proposed quorum matches Lombard's Prairie Food Co-op, another start-up co-op in Illinois with 1948 owners.

#### Discussion Item: Issuance of Preferred Shares

In order to offer Preferred Shares as a tool to raise capital, we must amend of our State of Illinois articles of incorporation.

Under current bylaws, such an amendment requires an affirmative vote of 2/3 of all existing shareholders.

The 2/3 requirement made sense when the co-op was small, but with 1500+ shares sold it's now unrealistic.

The proposal permits approval for an amendment to articles of incorporation with an "affirmative vote of two thirds (2/3) of the shareholders present and voting at a duly held meeting at which a quorum is present."


#### Board candidate: Martin Nobs

#### Board candidate: Frankie Garcia






